## Kansas Academy of Science Fall Board Meeting Minutes for Saturday, October 22, 2011 Cross Timbers State Park

- 1. Meeting called to order, 3:37 pm
- 2. Reviewed minutes from 6/3/2011
  - A. Motion to approve minutes
    - i. Motion by SS, second by SL
    - ii. Motion carried; all approved, none opposed
- 3. Treasurer's report: Shaun Schmidt
  - A. Current KAS balance sheet reviewed
  - B. Profit and Loss statement
    - i. \$980 that was listed for income from the Annual Meeting should instead be listed with Member Dues
    - ii. It has been slow getting membership information after the annual meeting. This will need to improve in coming years
  - C. Bonding/Authorized signatures
    - i. Bonding for SS and SL (treasurer plus additional authorized signer)
    - ii. Cost: \$137, coverage: \$100,000
  - D. Status of Tax Exemption
    - i. Events: We first received a letter from the IRS saying our tax-exempt status had been revoked. This information was taken to our accountant, who said we should be fine. We then responded to the IRS, who told us we do not qualify for tax exempt status because our 2009 taxes were filed late. We took this back to our accountant, and we are waiting on this now.
    - ii. It was suggested we contact the IRS in person to work directly with them instead of through the mail
  - E. Our 24 month CD will mature in January 2012
    - i. At that time, it will be moved to Educational Credit Union (ECU) in Topeka, and put into a 3-year CD
      - Our other CD matures in February 2013; when it matures we will split it in half and put one into a 1-year CD and the other into a 3year CD
      - b. This way, we can have one mature every year
      - c. CDs will be moved to ECU in Topeka as they come due
    - ii. Motion for us to go into a plan of having one CD mature every year on 3-year cycles
      - a. Motion by SS, second by BM
      - b. Motion carried; all approved, none opposed
  - F. We have not had the books audited in a long time

- i. Professional audit is about \$5000
- ii. Perhaps we should consider an unofficial audit
- iii. Purpose is to protect the treasurer
- iv. It was suggested we check into someone in the Accounting/Business department at Washburn
- G. One of the checks written for KAS student research grants was lost
  - i. For a student at Baker University
  - ii. We will stop payment on the check and a new check was written
- H. Treasurer's Report submitted for acceptance
  - i. Motion to approve
  - ii. Motion by DH, second by RS
  - iii. Motion carried; all approved, none opposed
- 4. Membership report: Sam Leung
  - A. 206 members in KAS (as if Thursday, Oct 20)
  - B. We need better communication following receipt of dues at the annual meeting
    - i. We should try to establish a pattern of paying dues prior to Dec 31 for the following year
    - ii. We should also encourage lifetime memberships
  - C. Transactions of the KAS
    - i. 389 copies of the current issue
  - D. Secretary's Report submitted for acceptance
    - i. Motion to approve
    - ii. Motion by SS, second by BM
    - iii. Motion carried; all approved, none opposed
- 5. List of Candidates for Election of 2012 Officers
  - A. Responsibility of Past President, who was not present
    - i. Would have been included in current newsletter
    - ii. RS will follow up on this soon
  - B. We will need a Vice President and two at-large positions (3-year terms)
    - i. There were some willing people last year, but not elected
    - ii. Perhaps consider this time
  - C. It was suggested we encourage participation from other institutions to arrive at a more equal representation by schools in the state
    - i. Consider: Pittsburg State, Friends, and Sterling
    - ii. Probably no interest from KU or K-State
  - D. We will need to get a list out soon
    - i. We will have another mailing for this (Nov 15)
- 6. Committee report: Junior Kansas Academy of Science (Amy Strong)
  - A. Not present
- 7. KAS Bulletin report: Hank Guarisco
  - A. Recently purchased 10,000 copies at UPS store to take advantage of a sale
    - i. This should be enough copies for 2 or 3 years
    - ii. Also bought stamps and labels
    - iii. Total: \$425.19
